Overview – Devolution resulting in the reorganisation of Local Authorities is coming

Lancs CC looking at several options for reorganisation

RVBC – not interested but recognises that the changes are coming

Possibility of a referendum but queries as to how relevant this would be as push coming from Central Government

Possibility of RPC to approach RVBC regarding the management/ownership of certain assets including the Fort Street garages in the event of a reorganisation

Timescale – the suggestion is that the new unitary authority will be up and running by 2028

RVBC are accelerating their 5yr capital investment plan, aiming to deliver it in 2 years – full details in the attached report

Date for skip, scrap metal, rolling program of repairs

Rolling programme of works has commenced with the replacement of some of the damaged fences 2 Bonds have been refunded

Cllr Neary proposed 2 skips for Easter weekend (both to be put at the bottom of the allotments away from the gate to prevent other people disposing of their rubbish). Seconded by Cllr A Hanson Currently there are 2 vacant plots

Cllr R Hanson to send Cllr Neary the breakdown of the allotment costs to share with the allotment holders in a letter to explain the future increases in rent and in the bond for each allotment as costs have risen, especially when plots are left in very poor condition. Significant usage of the lengthsman, mainly on allotments, resulting in £4800 in costs.

10) Decision Items

- (A) Football lease update Read FC is disbanding, Readstone FC have expressed an interest in taking over the lease however they would like it rewording so that they can apply for the FA funding for pitch improvements. They will get the draft drawn up and will present it at the next meeting
- (B) Clerk Vacancy 4 Applicants, interviews being held on 6th March (Cllr Hacking, McKelvy and Neary to interview)
- (C) Unity Bank/Barclays/finance update Barclays accounts closed and switched over to Unity which has been up and running for a few weeks now, online payments now being made. Cllr R Hanson suggested that the Skipton Savings account be closed, and the money to be put into

the Unity savings account to improve efficiency and ease of movement for any future large projects. Cllr McKelvy seconded the motion

- (E) Back Street lighting Cllr Neary has approached a local resident on Fort Street who has given permission for a solar light to be attached to her gable end. Councillor Andreson to investigate the cost of lights
- (F) Car Park camera Deferred to next meeting as the council is waiting for The pole to be erected first
- (G) Mirrors for side streets onto Whalley Road Deferred to next meeting at Cllr Greenhough is waiting for a response to her request for information and guidance from Lancs CC
- (H) Planter to replace phone box Cllr Pollard has a range of pricing for the planter and will speak with Borough Cllr Peplow regarding the possibility of a grant to cover some or all of the cost
- (I) Internal Auditor payment Payment agreed
- (J) VE Day donation to RSVH Cllr Hacking proposed a donation to the VE day celebrations of £140, Cllr A Hanson seconded it
- (K) Playground equipment (bike, rower, swing seats) Cllr Greenhough to gather information and prices for the next meeting together with Cllr McKelvey. Cllr Pollard to communicate with Borough Cllr Peplow regarding the possibility of any grant funding towards this through the Healthy Partnership scheme or any other sources of available funding
- (L) Community allotment Plot 11A Cllr Anderson to investigate the issue of flooding, if this can be resolved then there is a possibility of leasing this to REG as a community allotment, to be discussed at the next meeting
- (M) Biodiversity Grant for REG No objection from the Council for REG to apply for this funding directly
- (N) Devil's Elbow road surface condition Cllr McKelvey to write a letter from the Council to County Councillor Mirfin regarding the huge number of complaints regarding the state of the roads
- Cllr Neary has also put in a complaint vis the LoveOurStreets app.
- (O) Future house building location Councillors to look at Read and identify potential areas for housing that would cause the least impact and report back at the next meeting
